AMENDMENT TO THE BY-LAWS OF ANDOVER FOREST HOMEOWNERS ASSOCIATION, INC.

This AMENDMENT TO THE BY-LAWS (the "Amendment") is made this May of day of _______, 2020 by the Members of ANDOVER FOREST HOMEOWNERS ASSOCIATION, INC (the "Association").

WHEREAS, the Association was established pursuant to the Declaration of Covenants, Conditions and Restrictions for Brighton Place Subdivision, of record at Book 1519, Page 302 in the Fayette County Clerk's Office (the "Master Deed"), as subsequently amended and supplemented;

WHEREAS, the Association adopted the By-Laws of Andover Forest Homeowners Association, Inc. pursuant to Article IX of the Association's Articles of Incorporation;

WHEREAS, Article VI, Section 6 of the By-Laws states that the By-Laws may be amended by the affirmative vote (in person or by alternate) or written consent of Voting Members representing seventy-five percent (75%) of the total votes of the Association (the "Super-Majority");

WHEREAS, pursuant to Article II, Section 11 of the By-Laws, the required quorum for a meeting of Members is thirty percent (30%), and such requirement has resulted in difficulty establishing a quorum for essential functions such as election of Directors;

WHEREAS, the Super-Majority have consented to amend the By-Laws by written ballot.

NOW THEREFORE, pursuant to the consent and approval of the Super-Majority to amend the By-Laws, Article II, Section 11 of the By-Laws is hereby deleted and replaced in its entirety as follows:

<u>Section 11. Quorum.</u> Except as otherwise provided in these By-Laws or in the Declaration, the presence in person or by designated alternate of the Voting Members representing fifteen percent (15%) of the total vote of the Association shall constitute a quorum at all meetings of the Association.
